

Your suggestions and recommendations are welcomed and in fact encouraged, but send them to us; don't "help" us by contacting potential suppliers.

Even though the logic behind a reunion every two years may be good for some of you, a lot of enthusiasm is lost by waiting that long. The few reunion groups that we manage who meet every two years consistently have lower attendance than those who meet annually. It is an established fact that everyone can't come to every

reunion. If someone misses a biannual reunion, it's four years between events. That length of time takes away a lot of that gung ho spirit. We had a lot of recently found people who could not attend the Las Vegas reunion, but were looking forward to "next" year. They are going to be disappointed! I don't know what can be done now that the decision has been made, but for future reference, consider the above.

We understand that a member of the group has volunteered to publish a newsletter for you, so this will be our only direct correspondence with you. Perhaps we can submit a column for publication in your newsletter to keep you updated on reunion activities. Many times publishing your own newsletter works well, many times it does not. The problems usually arise - not with the writing of the newsletter but - with the "hidden" aspects of the newsletter. For example, as part of our commitment to you, we have established and will maintain the master data base. All " new finds" and address changes are sent here; by combining your newsletter with other mailings the postage can be cut nearly in half. Unless each piece is sent "regular mail" at \$.33 you must have a postal permit. In order to get the permit you must meet a variety of postal requirements. We have a postal approved computer program that changes incorrect addresses (it does not track moves), prints address labels in the required order, as well as adds the barcode and last four zip code digits. Finally, when mail is returned because of a change of address, there is a fifty cents charge to the sender. I don't mean to be discouraging, but the above items must be taken into account - unless everything is sent "regular" mail. That will solve all of the problems except the data base dilemma. I am very afraid that if two separate data bases are set up, neither will receive all of the names and addresses and some people from both lists will end up not getting mail. However, unless we hear differently, your newsletter will be published internally. If permitted, we will submit a column advising you of "new finds" and reunion information. That's "Our View".
