One time in my life I wanted to share. It was emotional, and I became a better man for what happened. Perhaps someone out there remembers the evening. I will never forget it.

One night back at Site Six (6) just up the road on Route 327 from Hahn Air Base. This did happen, and I prayed it was just a mistake, although at the time we were not sure of what was going on.....

It was a night like all others when we were in the maintenance quarters off the launch pad doing the normal things we would do around 11:00 PM. There was the normal cleaning up of the kitchen, polishing the floors, drinking coffee, and for many a game of cards. After all the place was quiet, and all maintenance was finished. Security guards walked the fence and occasionally stopped in for a cup of coffee and a few words with the card players. They maintained security and it was a boring, but necessary job. It's time to address a problem that got serious this



Just as fast I realized that it was one big mistake. Oh, by the way we never did hear that voice again on the radio.

I know after that experience that what we did over in Germany was important and I never took that Siren for granted again. I grew up that evening and so did many other young men assigned to the Missile Site. To this day, I can still remember the words "General Alert War Message" and I pray that our men and women in the Armed Service will never have to experience that feeling as I felt close to 40 years ago.

Each and everyone associated with the effort is to be "Thanked". Yes, we are older! Yes, we are having our health problems, but a few years ago we made a contribution. Look back you guys.....you contributed to our current way of life. I am proud of everyone in every job that was connected with the Matador and Mace Missiles. Stand Proud you did a "Great Job" !!!!

WHERE WERE YOU IN '62?

One major world crisis which occurred during the years our tactical missiles were deployed was the October 1962 Cuban missile crisis. Despite the passage of years, I can vividly recall the deadly serious way we responded to the possibility we might actually fire our birds in anger. The story by Ron Schwartz made me think about what might have been, and just exactly how close we were to a hot war in 1962.

I'd like to do a composite story about how this event was viewed by all of you. To make this work, I need

your input. By coincidence, the Association of Air Force Missileers is also doing something like this, but honestly, I was planning on doing this for several months.

If you would please send me a brief summary of the events that stood out in your mind during that crisis, I'll do my best to compile the thoughts. It need not be a long, detailed account, just a few words describing your indelible memories.

MAIL CALL!

The mailbag was full again, as usual. Lots of letters from new folks who found out about our group on the website.



One letter in particular caught my attention because it points out that passing years sometimes fade our memories, and some things we would swear to in court might not have been exactly as we remembered. I decided to print Harry

Yates letter because it was interesting and because it questions information previously printed in this newsletter. I had to edit slightly to make it fit, but I think I caught most of your points, Harry.

"I just finished reading the latest newsletter. I'm bewildered by the difference in the impressions I received of the Mace/Matador (the TM61C is the only one I had anything to do with).

First, I was not a missileer; I was in the communications squadron. I transferred PCS from a jet fighter wing at Clovis AFB, NM as a SSGT, 29351 Ground Radio Operator. This was in 1956. I don't even remember the season, much less the month. I was sent to Orlando AFB where the Matador missile wing was located, and it was from there that all of the maneuvers of the TM61C Matador were made. Actual launches of course were done at Cape Canaveral.

My interest in the missile itself was such that I never went to the Canaveral launch area. We lived in tents in Palmetto Park, or Rattlesnake Ridge, whatever you want to call it. The area had been bulldozed and smoothed, and PanAm sprayed around our camp regularly. We worked out of a SCR 399 mobile radio outfit. At least a half-dozen radio operators when only one was on duty at any one time, so most of our time was spent on the beach which was just across the single highway on the cape... probably 500 yards to walk.

When word got out there was a bunch of GI's camped near there, the beach became crowded. On late nights, if there was a breeze from the ocean inland to keep off the mosquitoes, you had to be careful when you walked on the beach. It wasn't considered polite to step on someone when he's just about to get her cooperation... or even afterward. Believe me, it was very romantic.

Back to what I started out to do, the difference between my missile and theirs, and I welcome comments on what I remember.

I remember the missile propulsion system being testfired from a horizontally held-down missile. It must have been regular, because there was a cock pheasant which used to get behind it and preen himself up in the blast of hot air and fumes. I also remember picking up palm-sized pieces of the solid fuel that powered the missile...very handy for starting fires.

Sometime in 1957, we were sent to Formosa as a unit. It took two fully loaded C-124's to carry all the forward troops and equipment. This was one of only two unit moved I made during 26 years in the Air Force. The other one was with the 22nd Bomb Wind from March AFB to Ellsworth AFB in 1970. I was flying the PACCS/ABNCP, EC135E aircraft then. By the way, I got the missile badge from there. The PACCS aircraft had control of all ICBM's at the time.


I correct myself...the testing of the engines was in Formosa. I also used to watch them pass overhead when they would be test fired. I was on Makung Island, the forward guidance site. I knew the pilots who flew the chase aircraft...T-33's... and they would call and tell me when to look for them.

We were the first military group to go to Tainan Formosa. Previously there were only a couple of MAC advisors. They were ready for us though. There were already at least half a dozen bars complete with bar girls...and more opened all the time."

HISTORY OF THE TACTICAL MISSILE...PART 3

This is the third in a series of articles condensed from the two-part feature in the Spring and Summer issues of International Plastic Modelers Society/United States Branch, Quarterly. The authors were our own Fred Horky and a Dr. Griffin T. Murphey. Each author had submitted his own manuscripts, but the magazine editor combined them. Fred wants us to know that he does not agree with some statements in the combined story, but is sharing them "as is".

The Mace A was not intended to be moved on the ground with the nose and warhead sections attached. This was due to the relative fragility of the vacuum-tube electronics, "low bridge" vertical clearance requirements, and certain warhead safety rules. Instead the special Nose and Booster support equipment was installed on a separate MM-1 truck, to transport both the nose (including warhead) and booster rocket. However, when the missile was publicly displayed-as in President Eisenhower's second inaugural parade-it was usually transported intact. This is why most photographs show it on display or under tow fully assembled.



The APW-11 transponder, which had been used on the Matador as primary guidance, was installed on development and test Mace missiles as a back-up, range safety system in the event of ATRAN guidance failure. Flush antennas for the APW-11 were mounted above the aft fuselage on either side of the fin. This was installed to provide space for test and range safety equipment. It should be emphasized that neither of these removable fairings were installed on operational missiles.


On most test flights the warhead was replaced by a concrete dummy shape with the "bang" represented by a photo-flash cartridge for test range camera documentation. However, an alternative test mode was sometimes used which allowed the missile to be recovered, undamaged, for reuse. The entire warhead section was replaced by a "recovery section" which contained three large parachutes, as well as an air bag which resembled a life raft popping out on the bottom of the section with a similar one carried under the rear fuselage. After completion of the test mission, the engine would be shut by APW-11 remote command, and a drag chute deployed from the doghouse fairing. After the missile had slowed, the large parachutes would be

deployed to lower the missile to the ground, landing on the airbags. At one point in the test program, the usual deceleration phase failed to occur and the three 100-foot cargo chutes were popped at 600 knots with memorable results...only a few wing fragments landed by parachute. In another case at Holloman AFB, New Mexico, the RATO unit was known to fire accidentally, ripping through the bolted-down missile with it's 840 gallons of JP-4.

Unfortunately, the ATRAN could be jammed by the opposition and was never that reliable, so the TM-76A was operational for a scant year—and-a-half in Europe. Probably the only time it came to national attention was years later when it had been given the ignominious role of target drone as the MQM-13A.

The retired Mace missiles were often launched from Eglin AFB by missile crews in training. Then interceptors would attempt to shoot the missiles down as part of their training. Since the MQM-13A Mace could be programmed to take evasive action and since turns were assisted by spoilers, the craft could "turn on a dime". Fighters were rarely successful at shooting the Mace down unless they screamed in just at the moment of launch and hammered it before it could make its first turn. On one memorable occasion, a Mace missile failed to auto-destruct and began flying toward Cuba. One F-4 fired Sidewinders which exploded, causing damage to one wing. However, the spoilers on the other wing popped up and righted the craft, which continued on toward Cuba. A second F-4 emptied its 20mm gun into the Mace, with no effect, due to bullet-deflecting fuselage and honeycomb wing-empennage structure. The missile in fact flew on over Cuba, creating an international incident.

To avoid similar incidents in the Pacific close to mainland China, no Mace-Bs were ever launched from their Okinawa bases. However, hearsay has it one TM61C Matador did get away from its Formosa based launch control some time around 1956 and had to be put down by F-106s.
